

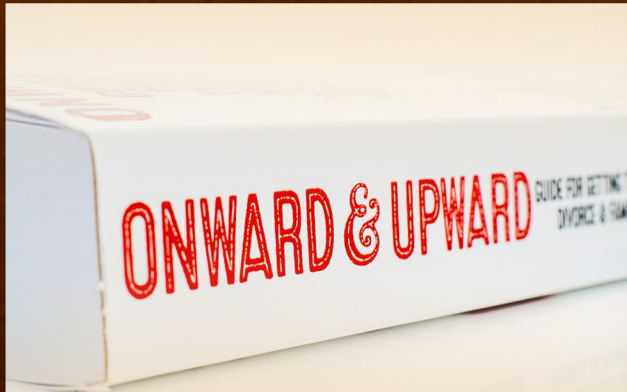


About Cari
